

**Stream Cleanup  
Liability and Photo/Video Release Form**

As a stream cleanup volunteer (and/or a parent or guardian giving permission for my minor child(ren) to participate in a cleanup), I agree to comply (and/or instruct my child(ren) to comply) with all safety guidelines communicated to me (and/or my child(ren)) by program organizers, to seek further clarification (and/or instruct my child(ren) to seek clarification) of any instruction not fully understood, and to exercise (and/or instruct my child(ren) to exercise) care and safety while participating in any program events.

If I am giving permission for my child(ren) to participate, I certify by signing below that I understand that cleanup organizers cannot provide supervision for minor participants. I further certify that I will provide, or have arranged for another adult to provide, supervision for my child(ren) age 13 or under during the cleanup, or that, if my child(ren) age 14 or over will be participating without supervision, that he/she/they is/are, in my judgment, sufficiently mature to participate safely and effectively without supervision.

As a stream cleanup volunteer (and/or a parent giving permission for my minor child(ren) to participate in a cleanup), I will at all times indemnify and save harmless the agencies, organizations and individuals sponsoring, organizing, and/or promoting this cleanup, including but not limited to the Virginia Department of Conservation and Recreation, the Commonwealth of Virginia, Fairfax County, Fairfax Trails and Streams, the Potomac River Greenways Coalition, the Alice Ferguson Foundation, the Fairfax Watershed Network, the Friends of Burke's Spring Branch, and all employees, agents, and officers of such agencies and organizations, from responsibility, damage, or liability arising from activities associated with the cleanup.

**By voluntarily engaging (and/or allowing my child(ren) to engage) in a stream cleanup activity, I personally assume all risks for any harm, injury, or damage during my (and/or my child(ren)'s) participation.**
